

DESCRIPTION

M11 Sanitising Wipes are impregnated sanitising wipes, which have been specially formulated for use within food preparation areas. They are also suitable for use within food processing and allied industries. The wipe is impregnated with a sanitising liquid which, when used, gives cleaning and disinfecting properties. The quick drying nature of the liquid makes it ideal for the disinfection of temperature probes, handles, handheld terminals, control panels, glass counter fronts, cutlery and condiment pots.

The impregnating liquid (Alcosan) has been independently tested by:

1. **Campden BRI** - assessed against and passes EN1276 (quantitative suspension test) @ 20°C in dirty conditions.
2. **Lab-Test Laboratorium SC** - assessed against and passes EN13697 (quantitative surface test) @ 20°C in clean and dirty conditions.
3. **Campden BRI** assessed against the Triangle Contact Taint test based on BS ISO 4120:2004 and is regarded as non-tainting.

USE INSTRUCTIONS

M11 Sanitising Wipes are a single use impregnated wipe. They should be used as required to disinfect surfaces following a clean and disposed of after use.
